**More Rain/Snow falls predicted in the country from 9<sup>th</sup> March- 11<sup>th</sup> March 2019 i.e  
Saturday (night) to Monday**

According to Pakistan Meteorological Department (PMD), a Westerly Wave is likely to enter Balochistan on Saturday (night) and parts of the country on Sunday. Under the influence of this weather system, widespread rain-thunderstorm and snowfalls over the hills (with isolated heavy falls) accompanied by gusty winds may occur in Balochistan from Saturday (night) to Sunday, whereas at scattered places in Sukkur, Larkana, Shaheed Benazirabad & Hyderabad Divisions, besides, at isolated places in Karachi Division on Sunday. Widespread rain-thunderstorm and snowfalls over the hills (with few moderate to isolated heavy falls) accompanied by gusty winds are likely to occur in Khyber Pakhtunkhwa, Punjab, Islamabad, Gilgit Baltistan and Kashmir from Sunday to Monday. The Heavy rain falls may generate flash flooding in local nullahs/Hill Torrents in Quetta, Zhob, Sibbi and Kalat Divisions on Sunday and may trigger landslides in Malakand & Hazara Divisions, Gilgit- Baltistan and Kashmir on Monday.

All concerned authorities are advised to watch the situation closely and take all necessary precautionary measures in order to avoid loss of human lives and damage to public infrastructure and private property.
