DAILY WEATHER & FLOOD SITUATION REPORT SUNDAY, SEPTEMBER 27, 2020

All main rivers (Indus, Jhelum, Chenab, Ravi and Sutlej) are flowing normal. Today's actual river flows and reservoir elevations may be seen at Annexure-I, which indicates that Tarbela & Mangla reservoirs are at elevation of 1548.40 feet and 1232.65 feet respectively i.e. 1.60 feet and 9.35 feet below their respective Maximum Conservation Levels of 1550.00 feet & 1242.00 feet. Today's Combined Live Storage of the country's major reservoirs is 12.662 MAF (93.01% of the total live storage capacity of 13.614 MAF).

- 2. Yesterday's trough of **Westerly Wave** over Northern parts of Pakistan today lies over Kashmir and adjoining areas whereas weak **Seasonal Low** still persists over Northeastern Balochistan and adjoining areas.
- 3. According to FFD, Lahore, isolated wind-thunderstorm/rain is expected over Punjab (**Rawalpindi, Gujranwala & Sargodha Divisions**) and Khyber Pakhtunkhwa, besides, upper catchments of Rivers Indus, Jhelum & Chenab during the next 24 hours. No prominent rainfall event has been reported by FFD, Lahore, in the country during the past 24 hours except for Kalam=08 mm, & Bunji=07 mm.
- 4. Pakistan Meteorological Department (PMD) is monitoring the prevailing weather system and keeping all concerned informed through FFD, Lahore.
