DAILY WEATHER & FLOOD SITUATION REPORT MONDAY AUGUST 23, 2021

Owing to ongoing subdued monsoon activity, there is no riverine as well as urban flood situation in the country. All main rivers of the Indus River System are flowing with "Normal Discharges". Inflows/outflows of major rivers at important control structures & storage position of major reservoirs alongwith Skardu temperature may be seen at Annexure-I. As of today, Combined Live Storage of Tarbela, Chashma & Mangla reservoirs is 10.179 MAF (75.31% of the total Combined Live Storage Capacity of 13.516 MAF).

2. Yesterday's trough of Westerly Wave over Northwestern parts of Afghanistan today lies over Northern parts of Afghanistan whereas weak Seasonal Low lies over Northern Balochistan. Mild Monsoon Currents from Arabian Sea are penetrating into upper parts of Pakistan upto 3000 feet.

3. Mainly dry weather over most parts of the country has been predicted by FFD, Lahore, during the next 24 hours. Nevertheless, isolated thunderstorm/rain may occur over **Punjab** (**D. G. Khan Division**) and **Khyber Pakhtunkhwa (Bannu & D. I. Khan Divisions**) besides over the upper catchments of rivers Indus & Kabul during the same period. No significant rainfall event has been reported by FFD, Lahore during the past 24 hours.

4. Pakistan Meteorological Department (PMD) is monitoring the present weather system and keeping informed all concerned through FFD, Lahore.
