Rain-wind/Thundershower prediction in the country from 20th -25th September 2021

Pakistan Meteorological Department has issued a Press Release based on the prevailing Hydro-Meteorological conditions over Pakistan stating that more monsoon currents are likely to penetrate in the country from 20th September (evening/night) and likely to continue till 25th September 2021. Under the influence of this weather system:

- Rain-wind-thundershower with Isolated Heavy Falls is expected in Islamabad, Punjab (Rawalpindi, Attock, Chakwal, Jhelum, Gujrat, Mandi Bahauddin, Sialkot, Narowal, Gujranwala, Hafizabad, Lahore, Okara, Faisalabad, Sargodha, Mianwali, Jhang, & Toba Tek Singh Districts), Khyber Pakhtunkhwa (Kohistan, Shangla, Mansehra, Abbottabad, Haripur, Mardan, Charsadda, Nowshera, Dir, Chitral, Peshawar, Kohat & Waziristan Districts), Kashmir and Gilgit-Baltistan (Ghizer, Astore, Diamir, Skardu, Gilgit, Hunza, Nagar, Ghanche & Kharmang Districts) with occasional gaps from 20th September (evening/night) to 24th September 2021.
- Rain-wind-thunderstorm with Isolated Heavy Falls is also expected in Southern Punjab (Bhakkar, Layyah, Sahiwal, Bahawalnagar, Dera Ghazi Khan, Rajanpur, Khanpur, Khanewal & Multan Districts), Khyber Pakhtunkhwa (Tank, Karak, Bannu, and D.I. Khan Districts) Eastern Balochistan (Kohlu, Loralai, Barkhan, Zhob, Musa Khel, Quetta, Ziarat & Kalat Districts) and Sindh Province (Karachi, Hyderabad, Mirpurkhas, Tharparker, Umerkot, Sanghar, Thatta, Badin, Dadu, Shaheed Benazirabad, Sukkur & Larkana Districts) from 23rd September (evening/night) to 25th September 2021.

With above likely Hydro-Meteorological situation in view, all concerned organizations are advised to take necessary precautionary measures well in time to avoid loss of precious human lives and damages to private & public property.
