DEPRESSION OVER THE NORTHEAST ARABIAN SEA

Pakistan Meteorological Department (PMD) has issued a Press Release stating that the Low-Pressure area (LPA) persisting over the Northeast Arabian Sea & adjoining Gulf of Kutch has intensified into a Depression (Intense Low-Pressure Area) with maximum wind speed of 50-55 km/hour. The system is located around Latitude 21.8N & Longitude 69.0E, at a distance of about 400 km southeast of Karachi and 340 km from Thatta. This weather system is likely to move in northwest direction during next 36-48 hours and move westwards towards Oman coast. Under the influence of this system, following weather is expected:

• Widespread wind-thunderstorms/rain-showers with scattered Heavy/Very Heavy Falls, Extremely Heavy at times, are likely in Sindh (Karachi, Hyderabad, Thatta, Badin, Mirpurkhas, Thaparker, Umerkot, Sanghar, Shaheed Benazirabad, Nosheroferoz, Tando Muhammad Khan, Tando Allayar, Dadu, Jamshoro, Sukkur, Larkana, Jacobabad, Shikarpur and Ghotki districts) from today 16th -18th July 2022 and Balochistan (Lasbella, Uthal, Ormara, Pasni, Gwadar, Jiwani, Turbat, Awaran and Ketch) areas during 17th - 18th July 2022.

Possible Impacts:

- Sea conditions would remain very rough during next 3 days.
- Very Heavy/Extremely Heavy Rains may generate Urban Flooding in Sindh (Karachi, Badin, Thatta, Hyderabad, Dadu, Mirpurkhas, Shaheed Benazirabad, Tando Muhammad Khan and Tando Allayar), and Balochistan (Lasbela, Sonmiani, Ormara, Pasni, Gwadar, Turbat and Jiwani).
- Windstorm may cause damages to loose & vulnerable structures.

With above likely Hydro-Meteorological situation in view, <u>all concerned organizations are</u> advised to remain **VIGILANT** and **HIGH ALERT**, and take all necessary precautionary measures well in time to avoid loss of precious human lives and damages to private & public property.
