**SIGNIFICANT FLOOD WARNING**

According to latest Hydro-Meteorological conditions prevailing over the country, FFD, Lahore has issued **Significant Flood Warning** stating that **River Chenab** at:

- **Marala** is likely to attain **High Flood Level** ranging between **250,000 to 300,000 Cusecs** from **28<sup>th</sup> July 2022 (1600 PST)** to **29<sup>th</sup> July 2022 (1000 PST)**.
- **Khanki** is likely to attain **High Flood Level** ranging between **250,000 to 300,000 Cusecs** from **0000 PST to 1800 PST** of **29<sup>th</sup> July 2022**.
- **Qadirabad** is also likely to attain **High Flood Level** ranging between **250,000 to 300,000 Cusecs** from **0600 PST to 2400 PST** of **29<sup>th</sup> July 2022**.

In view of the above situation, all concerned organizations in particular PDMA Punjab (including all concerned DDMA's), related district administration and related field formation of Punjab Irrigation are strictly advised to remain at **HIGH ALERT** and ensure taking all necessary precautionary measures well in time to avoid any loss of precious human lives and damages to private & public property, besides the irrigation & flood protection infrastructures.
