SIGNIFICANT FLOOD WARNING FOR RIVER RAVI

Pakistan Meteorological Department has issued Significant Flood Warning for River Ravi stating that India has released **1,71,797 Cusecs** from **Ujh Barrage** at **1530 PST**. Keeping in view the releases from Ujh Barrage, flows are likely to increase in **River Ravi** at **JASSAR** ranging between **70,000 Cusecs to 1,00,000 Cusecs (Medium to High Flood Level)** during the period from **0000 PST of 16-08-2022 to 1200 PST of 16-08-2022**.

2. Foregoing situation in view, all concerned organizations are advised to remain **Alert** and take all necessary precautionary measures well in time to avoid loss of precious human lives and damages to private & public property.
