SIGNIFICANT FLOOD WARNING FOR RIVER INDUS AT KALABAGH & CHASHMA

According to latest Hydro-Meteorological conditions prevailing over the country, FFD, Lahore has issued **Significant Flood Warning** stating that:

- **River Indus at Kalabagh & Chashma** may attain **High to Very High Flood Level** ranging between **550,000 cusecs to 700,000 cusecs** from **1200 PST of 27th August 2022** to **1200 PST of 28th August 2022**.

In view of the above situation, all concerned organizations including **PDMA/DDMA**s are advised to remain **Fully Alert & Vigilant**, take timely actions on warnings issued by the concerned organizations to ensure safety of communities living in low lying areas, public & private property besides irrigation, drainage & flood protection infrastructure etc.
