Chapter - 1

SALIENT FEATURES OF SIDHNAI HEADWORKS

1.1 Location

1. In 1960, Indus Water Treaty gave water rights of Eastern Rivers (Ravi, Sutlej, Beas) to India and rights of Western Rivers (Indus, Chenab and Jhulem) were given to Pakistan. In order to overcome the scarcity of 30 MAF water, World Bank assistance was valuable both on the technical and finance side as well as its role as a guarantor of the Massive structures known as Indus Basin Project. The Indus Basin Project comprises of construction of two Dams (Mangla and Tarbela), construction of five new Barrages and eight major link canals to pour 20 MAF water from the Indus and Jheulum to Ravi and Sutlej Irrigation command area.
2. Sidhnai Barrage was also constructed as one of the component of Indus Basin Project. It has been constructed about 6 miles upstream of the old Sidhnai weir almost 5 kilometers from Abdul Hakim city. The location of Sidhnai Barrage is unique in a sense that 11 No of its bays are in District Khanewal and 4 No bays in District Toba Tek Singh.

1.2 General Description

1. SIDHNAI BARRAGE

The meaning of the word “SIDHNAI” is Straight River. A stretch of eight miles of River Ravi at Sidhnai is nearly straight and does not meander. It is thought that it could be an artificial channel excavated in the distant past to prevent flooding in the Multan area.

Before Indus Water Treaty, the old Sidhnai weir with a maximum design capacity 100,000Cs was operational. The new Sidhnai Barrage was constructed 31000 ft upstream of old Sidhnai weir with design capacity of 150,000 Cs. Downstream straight reach was excavated and widened to increase the capacity from 100,000 Cs to 150,000 Cs. After demolishing old Sidhnai weir and Railway bridge new Railway bridge and road bridge on Multan Shorkot road were reconstructed at about 6500 ft and 31500 ft respectively downstream of Sidhnai Barrage. River Ravi falls into River Chenab near Fazil Shah village.

Recently Motorway M-3 bridge has been constructed at a distance of about 17000 ft downstream of Sidhnai Barrage. The object of new Sidhnai Barrage is to receive water from Chenab and Jhelum Rivers from Trimmu through T.S Link Canal and Haveli Main Line to feed off-taking canals of Sidhnai Barrage.

2. FEEDING CHANNELS.

After Indus water treaty, the water rights of all Eastern rivers were given to India that also includes river Ravi. In order to overcome the scarcity of water in river Ravi along with Haveli Main Line which is already playing a role of Feeding Channel to Sidhnai Weir, Trimmu Sidhnai Link Canal was also constructed. Hence the two feeding channels of Sidhnai Barrage are as under: -

- a) Trimmu Sidhnai Link Canal
- b) Haveli Main Line

a. TRIMMU SIDHNAI LINK CANAL.

T.S.Link canal was constructed to transfer River supplies of Jhelum and Chenab from Trimmu Barrage to River Ravi at Sidhnai Barrage. The total length of canal is 218,082 ft having discharge capacity of 11,000 Cs. A scheme namely “Rehabilitation of Trimmu – Sidhnai Link Canal (Controlling Seepage Water Logging along T.S Link Canal)” is underway under ADP whereby design parameters will be enhanced and discharge capacity of the channel will be increased from 11,000 Cs to 12,500 Cs.

b. HAVELI MAIN LINE.

Haveli Main Canal, with a capacity of 5,170 Cs., also off takes from Trimmu Barrage and runs parallel to the T.S.Link and after supplying water to the distributaries, it also falls into the River Ravi giving additional supply of 3,700 Cs to the Sidhnai Barrage.

3. OFFTAKING CHANNELS

2 No channels off takes from the left flank of Sidhnai Barrage. These off taking channels irrigate the most fertile land of Multan, Khanewal, Vehari, Bahawalpur, Lodhran, Pakpattan and Rahimyar Khan Districts etc.

The names of the channels are as under

- a) Sidhnai Mailsi Link Canal.
- b) Sidhnai Canal.

a. SIDHNAI MAILSI LINK CANAL.

It was constructed to transfer water from River Ravi to Lower Bahawal Canal through a Syphon at River Sutlej near Mailsi. Its designed capacity is 11,300 Cs with a total length of 374,983 ft. It is an unlined channel up to RD: 76+221 and lined from RD: 76+221 to Tail. It also supplies canal water to Lower Pakpattan Canal and Lower Mailsi Canal. This canal supplies water to fertile lands of Khanewal, Vehari, Multan, Lodhran and Bahawalpur Districts.

b. SIDHNAI CANAL

Initially Sidhnai Canal was fed from old Sidhnai weir. After the construction of new Barrage at present site, Sidhnai Feeder Canal was constructed to feed Sidhnai Canal from new Sidhnai Headworks. Now L-Section of Sidhnai Canal has been revised and Sidhnai Feeder has been merged into Sidhnai Canal. This canal supplies water to Khanewal and Multan Districts. Its designed capacity is 4005 Cs with a total length of 185+761ft.

4. U/S FLOOD EMBANKMENT.

In order to overcome the afflux produced due to construction of Sidhnai Headworks, 02 No. Marginal Flood Bunds i.e Left Marginal Bund and Right Marginal Bund have been constructed to channelise the river flow through the Headworks.

a. LEFT MARGINAL BUND (LMB)

The L.M.B has a length of 89,585 feet with a design width of 25 ft with river side slope as 2:1 and country side slope as 3:1. The designing of flood bund is based on 1988 flood. It has a free board of 6 ft. Left Marginal Bund has been provided with a ring bund starting from Bund RD:13+500 to RD:14+500. A Mole Head Spur at RD:15+000, X-Spur at RD:16+900 & RD:31+000 and J-Head Spurs at RD:20+800 & RD:38+000 have also been provided on the L.M.B. Four No. soild stone spurs having length 235 ft have also been provided.

b. RIGHT MARGINAL BUND (RMB)

The Right Marginal Bund has 115,000 feet with a design width of 25 ft with river side slope as 3:1 and country side slope as 3:1. The designing of flood bund is based on 1988 flood. It has a free board of 6 ft. Right Marginal Bund has been provided with J-

Head Spur at RD:99+500 and X-Spur at RD:108+500. The Right Marginal Bund has also been provided with wetting channel from RD: 0+000 to RD:11+000.

5. D/S PROTECTION BUNDS.

The Left and Right embankments of old Sidhnai weir were converted into Left and Right Protection Bunds of Sidhnai Headworks. The total length of Left and Right downstream protection bunds is 31000 ft.

6. U/S GUIDE BANK.

Sidhnai Barrage has been provided with Guide Bank upstream right side. The Guide Bank is totally covered due to masking on Right side.

7. SPILL CHANNEL.


Spill Channel has been constructed to reduce the flood thrust on old Sidhnai weir in 1959 with a design capacity of 30,000 Cusecs but excavated for 20,000 Cs. After the construction of new Sidhnai Headworks, only head regulator was renovated for a capacity of 45000 Cs as Indus Basin Scheme and the rest of the channel is yet to be renovated. Therefore, after the construction of Sidhnai Headworks, spill channel never received its design share even in the extreme flood conditions. The maximum flood discharge ever flowed in Spill Channel was 21,968 Cusecs in 1988. The spill channel needs a comprehensive renovation and rehabilitation. The total length of spill channel is 69602 ft. The importance of spill channel has increased a lot after the construction of Motorway. Although National Highway Authority has submitted an undertaking for safe passage of water from flood opening provided by them yet irrigation authorities have great concern on it.

8. BREACHING SECTION.

A breaching section was approved between RD:15-16 R.M.B. A critical gauge has been provided at RD:10+000 Left Marginal Bund to watch the thrust of the flood. On achieving the flood level as 478.00 at this critical gauge and while the river is still in raising position, the breaching section at RD:16+000 Right Marginal Bund is activated. It has been estimated that a discharge of about 45,000 Cs will pass through breaching section, if operated. This breaching section was operated during 1973, 1976 and 1988 to pass the excessive discharge. Location plan of breaching section is attached.

1.3 ADMINISTRATIVE SETUP.

Sidhnai Headworks Division, Sidhnai has three Sub Divisions located at Sidhnai Headworks, Shorkot Cantt: and Kacha Khuh. The Administrative Setup of Sidhnai Headworks Division, Sidhnai is as under: -



Chapter - 3

BRIEF HISTORY OF PAST FLOOD EVENTS

The highest flood passed on 2-10-1988 in the history of Sidhnai Barrage at River Ravi. The total discharge U/S Barrage was 3,30,210 Cs out of which 2,55,012 Cs passed through weir of Barrage, 45,000 Cs through the Breaching Section and 21,968 Cs was passed through the Spill Channel. The H.F Level U/S of the Barrage recorded at Principle Gauge (LMB RD 10+000) was 478.20 while the HFL U/S of Sidhnai Barrage was 477.88 and D/S Gauge was 477.60. However, despite passing 2,55,012 Cs against 1,50,000 Cs design capacity, the structure of the Barrage remained safe. The flood also seriously affected the area on the right side upstream of Sidhnai Barrage particularly in Pir Mehal area. The right protection embankment of newly constructed Chichawatni Bridge had to be cut to provide relief to the bridge. The flood water from these cuts inundated the area on both sides. The downstream structure wing wall was raised by 4.00 ft after that highest flood for providing safe freeboard.

After the exceptionally high flood of 1988, very high floods passed through the barrage in 1995 and 1996 having discharge of 2,12,340 Cs and 1,95,362 Cs respectively. During these floods, the J-Head spur at RD: 38+000 LMB was under the direct hit, which was saved through hectic flood fighting.

Breaching section was operated during the year 1973, 1976, & 1988.

R.M.B was breached during the year 1988 at RD: 40-41.

Chapter – 5

FLOOD FIGHTING STRATEGY

1. LOW FLOOD

When River Ravi at Sidhnai Barrage reaches above 30,000 Cs, it is in low flood. At this stage flood water remains within the lips of the River. It does not touch any flood embankment. However, one No. Beldar per mile per shift of 12-hours is engaged on L.M.B and R.M.B and other X-spurs for upkeeping of these bunds.

2. MEDIUM FLOOD

Beyond 45,000 Cs and upto 60,000 Cs, River is in medium flood. At this stage, water starts touching the flood embankment. Strength of the Beldars is doubled to meet with any emergency. An additional Sub Engineer is deputed on L.M.B and R.M.B to assist the Sub Engineer L.M.B and R.M.B sections. Flood material is placed on various huts along R.M.B and L.M.B and night watching by the Sub Divisional Officer, Sidhnai H/Works Sub Division and Executive Engineer, Sidhnai H/Works Division, is carried out.

3. HIGH FLOOD

When discharge U/S increases from 60,000 Cs, the flood water is accumulated along R.M.B and L.M.B. Additional Sub Divisional Officer is deputed to assist Sub Divisional Officer, Sidhnai H/Works Sub Division for day and night watching. Beldars work in 3-shifts, each of 8-hours. Additional Sub Engineer from T.S Link Sub Division and Kacha Khuh Sub Division will work on L.M.B and R.M.B. Special night watching is carried out on J-Head spurs RD:20+800, 38+000 L.M.B and 99+500 R.M.B. Executive Engineer, Northern Tubewell Division (NTD) Multan is also deputed at this stage to help and assist Executive Engineer, Sidhnai Headworks Division, Sidhnai.

4. VERY HIGH FLOOD.

When discharge increases beyond 90,000 Cs, special day and night watching is carried out and all the officers move round the clock. Special attention is given for the protection of main Barrage, structure and gauges are observed after every one

hour. The staff present on breaching section at RD:16 R.M.B is highly alerted and keeping in view the rising condition of River Ravi D/S Balloki, presence of explosive in the liners is ensured.

5. EXCEPTIONALLY HIGH FLOOD

At this stage River Ravi is in rising condition and flows with more than 120,000 Cs whereas the design capacity of the Barrage is 150,000 Cs. All the staff is alerted. Superintending Engineer, Trimmu Canal Circle, Trimmu resides at the Barrage and critical gauge at RD:10+000 L.M.B is continuously watched. As soon as the critical gauge reaches at the level of 478.00 ft. and is further rising, operation of the breaching section is carried out by the Pak Army, 176 Bridge Battalion, Abdul Hakim Cantt: and all the people / local inhabitants are informed well before time to vacate their dwellings. The spill channel is operated, before operating the breaching section, if the river is likely to fall when the critical gauge is going to touch the limit of 478.00.

FLOOD DAMAGE RESTORATION WORKS AND OTHER REPAIR WORKS CARRIED OUT

No flood damages occurred during flood season 2022. Hence, no flood restoration / repair work carried out.

Chapter – 7

Flood Fighting Watching Arrangement

7.1 Pre-Flood Arrangement.

All the bunds are being inspected by a Committee constituted by the Secretary to Government of the Punjab, Irrigation Department in May every year. Inspection of all bunds and spurs by the Team of Military personals will be carried out before the flood season 2023 to ensure that the bunds are safe against the coming flood season.

Camps will be established on all vulnerable sites to monitor the situation during flood season. Cell phones, wireless sets will be provided and generator will be installed at important / vulnerable reaches. The flood watching material will be procured and will be shifted to the camp sites.

Keeping in view the possibility of receiving floods, precautionary measures will be taken from 1st July to 15th October. Watching establishment will be employed for the flood season as per limits of flood already fixed for various magnitude of Discharge in River Ravi.

7.3 ARRANGEMENT AT SENSITIVE SITES

- i) The normal strength for watching at sensitive sites along flood protection and River training works will be doubled during high flood / exceptionally high flood.
- ii) The establishment can be increased after consultation with Executive Engineer, Sidhnai Headworks Division, Sidhnai / Superintending Engineer, Trimmu Canal Circle, Trimmu in emergency & in accordance with site requirements. The same establishment will be responsible for maintenance of flood bunds and Spurs Shank etc. during 2022. It will arrange minor repairs to bund top, side slopes, removal of Sarkanda on pitched part of spurs. Establishment will also be responsible for filling gharas / rain cuts etc as occurred due to rains during the monsoon season.

Chapter – 11

Standard Operating Procedure (SOP) for Breaching Sections

11.1 HISTORY OF THE BREACHING SECTION

In order to protect the Barrage and its auxiliary works from onslaught of the floods, the proper site for breaching section has been fixed by the Department at RD:16+000 of Right Marginal Bund of Sidhnai Barrage, after its approval by the Punjab Flood Commission during its 56th meeting held on 17th June 1974. A critical gauge has been provided at RD:10+000 Left Marginal Bund to watch the thrust of the flood. On achieving the flood level as 478.00 at this critical gauge and while the river is still in raising position, the breaching section at RD:16+000 Right Marginal Bund is activated. However before activation of the breaching section, the spill channel provided at RD:15000 Right Marginal Bund is operated to give maximum relief to the Barrage against the thrust of floods. The water flowing through the Breaching Section and the Spill Channel ultimately enters into the old course of the river and after traveling a distance of about 20 miles, it joins the river as experienced in the past. The existing arrangement regarding Breaching Section is for the safety of the Barrage and infrastructures.

11.2 LOCATION, DESIGN, QUANTITY AND VARIETY OF THE EXPLOSIVE REQUIRED FOR DETONATION

The breaching section is located at RD:16+000 of Right Marginal Bund U/S Sidhnai Barrage. There are two segments of the section, each contains 65 Nos liners. Two types of explosives can be used in the liners, one is powder explosive and other is liquid explosive.

For detonation, both types of explosives are lying in the Army magazine 176 Bridge Battalion, Abdul Hakim.

11.3 ARRANGEMENT OF EXPLOSIVE AND SECURITY OF EXPLOSIVE STORES.

The explosives are in the custody of the Pak Army, 176-Bridge Battalion, Abdul Hakim. Therefore, the Army Unit 176 Bridge Battalion, Abdul Hakim, is responsible for availability, arrangement and security of the explosive stores.

11.4 LIST OF THE SECURITY STAFF WITH DETAIL OF THEIR TRAINING ETC.

Although the maintenance of entire explosive and its detonation, when required, is the responsibility of the 176-Bridge Battalion Abdul Hakim;However, the Executive Engineer, Sidhnai Headworks Division, Sidhnail and Sub Engineer Headworks have been trained by the Army for the detonation of the breaching section.

11.5 DETAIL OF MECHANICAL MEANS AS A STANDBY ARRANGEMENTS IN CASE OF DETONATION FAILURE

Although there is no regular standby arrangement of mechanical means available with the department for operation of the Breaching Section in case of detonation failure but the requisite arrangement is planned to be made, when required, with the coordination of local Military authorities, Agriculture Engineering and Highway Departments.

It is proposed to keep two No. agriculture dozers available at site at very high flood level. One No. dozer will be used for closing any leakage and the other for

developing, the cut at breaching site on RMB-Head Spill Channel. Sub Divisional Officer, Headworks Sub Division, Sidhnai, will ensure availability of the machinery and its being in perfect order.

11.6 DUTY ROSTER IN CASE OF CRITICAL SITUATION

Sub Divisional Officer, T.S Link Sub Division, Shorkot Cantt: Sub Engineer, Spill Section, and other establishment will be present at Head Spill to watch and control the situation for operating the breaching section. The Executive Engineer, Sidhnai Headworks Division, Sidhnai will supervise the situation and remain vigilant about the critical gauge, provided at RD:10+000 of Left Marginal Bund. As soon the gauge hits the critical level i.e. 478.00 and the river is still in rising condition, the requirement of operating the breaching section be established. The rising/ falling condition of the river in the forthcoming hours is assessed by receiving 3-hourly gauges from Balloki.

As soon as the flood at Balloki reaches at a very high stage and it is still in rising position, flood situation is brought to the notice of Civil Administration and Army authorities so as to inform the public and arrange their evacuation. The operation of the breaching section will be intimated to Army authorities by the Executive Engineer, Sidhnai Headworks Division at least 12-hours in advance as desired by the Commanding Engineer, 2-corps Multan for making arrangement to shift their explosive to the breaching site.

Similarly, the Civil Administration is also informed about the operation of breaching section at least 12-hours in advance.

11.8 LIST OF VILLAGES LIKELY TO BE INUNDATED IN CASE OF BREACHING

As indicated on the map as well, water escaping from the activated breaching section & Spill Channel will flow along Right Bank of Spill Channel. Due to construction of Motorway M-3 and M 54 which will act as barrier in flood routing,

expectededly. The flood water due to obstruction would create an afflux U/S of Motorway. The higher authorities including Pak Army is on board for this issue. The decided new flood drainage structure has not been implemented at site. Hence, the Motorway authorities would be responsible for draining the flood water across M-3 and M-4.

The flood water will inundate Multan – Jhang Road at about 85-KM from Multan, breach tail portion of Koranga Disty & thus will join river Ravi after traveling a distance of about 20 miles. The flood water flowing on the right, as mentioned above, will inundate/ damage an area of about 84,000 acres & the villages, abadies and other infrastructures, like roads and embankments are detailed as under:-

3. Mai Saphoran

11.9 ANNOUNCEMENT AND DETAILS OF EVACUATION ARRANGEMENTS.

Since time lag for the flood water to reach from Balloki to Sidhnai Headworks is 78-hours, Irrigation Department has sufficient time to inform Civil Administration about the flood situation for warning the civil abadies, their evacuation and other protective measures.

11.10 DETAILS OF COORDINATION WITH CIVIL/ ARMY AUTHORITIES

The flood activities of Sidhnai Headworks Division, Sidhnai have been entrusted to 176 Bridge Battalion Abdul Hakim Cantt: under the control of a Lt. Colonel. The Irrigation Department has full co-ordination with the Bridge Battalian regarding all the activities of the flood.

11.11 PARALLEL COMMUNICATION ARRANGEMENTS.

Sidhnai Headworks Division, Sidhnai linked up with the Wireless system installed at Sidhnai Barrage. Independent wireless sets will be installed in the vehicles of the Executive Engineer and the Sub Divisional Officer in-charge of the Barrage. Additional wireless sets will be demanded as per requirement during emergency.





12.1 Apprehended breaches in flood bunds / structures

There is one vulnerable reach at RD:32+000 Right Marginal Bund.

12.2 Operation of Breaching Section.

When the breaching section is operated, the embankment of Motorway M-4 will obstruct the flood water way and hence the efficiency of breaching section as well as right embankment of spill channel will directly come under threat from RD:0+000 to RD:31+000. Although National Highway Authority has submitted an undertaking that the flood structure provided by them are sufficient to drain flood water without any damage to infrastructure yet irrigation authorities has great concerns.

12.3 Breaches Due To Rising of Flood Water, Deterioration of Flood Bunds Etc.


Sidhnai Barrage has a design capacity of 150000 Cs. Since its date of construction, an earthen bela is formed on right side of Barrage and has masked up almost 6 to 8 gates of Sidhnai Barrage. It is very important to mention here that due to this bela, the discharge capacity of barrage will definitely be reduced, resulting in raising upstream flood water and an early operationing of breaching section as compared to historical data.


