FLOOD WARNING FOR RIVER KABUL AND ITS TRIBUTARIES

According to latest Hydro-Meteorological conditions prevailing over the country, FFD, Lahore has issued **Flood Warning** stating that a **Moderate to Strong** westerly wave is likely to affect **Khyber Pakhtunkhwa** from **26**th **April 2024**. Under the effect of this weather system,

Moderate to Heavy with Isolated Very Heavy Rainfall is expected over the upper catchments of River Kabul and its Tributaries, during the period from 27th to 29th April 2024 which may result in Medium to High Level Flood in River Kabul & its Tributaries during the period from 27th to 30th April 2024.

In view of the above situation, all concerned organizations in particular PDMA Khyber Pakhtunkhwa (including all concerned DDMAs), related district administration and related field formation of Khyber Pakhtunkhwa Irrigation are advised to remain on **ALERT** and ensure all necessary precautionary measures well in time to avoid any loss of precious human lives and damages to private & public property, besides the irrigation & flood protection infrastructures.
