
Sub: MONSOON SEASON-2024-SETTING UP OF FLOOD COMMUNICATION CELL (FCC) IN THE OFFICE OF CHIEF ENGINEERING ADVISOR & CHAIRMAN, FEDERAL FLOOD COMMISSION, ISLAMABAD

Every year Monsoon Season officially starts w.e.f 1st July. For the ensuing Monsoon Season-2024 as per previous practice, the Flood Communication Cell of FFC is being established in the Office of the Chief Engineering Adviser/ Chairman, Federal Flood Commission, that would start functioning two (2) weeks in advance on Round-the-Clock basis (24/7 basis) with effect from **June 15, 2024. Dr. Muhammad Ejaz Tanveer, Superintending Engineer (Floods-I), FFC**, would be the Focal Person for the entire duration of Monsoon Season-2024.

2. The Flood Communication Cell (FCC) will obtain weather & flood forecasts, besides, reservoir levels inflows/ outflows and river flows data from WAPDA Lahore, from FFD Lahore/ PMD Islamabad trans-border water/ flood flow information/ data from O/o PCIW including all related information from Flood Warning Centers set up during the Flood Season in the Provincial Headquarters. Information with regard to rainfall and projected river flows at important river locations, cities, coastal areas etc. would also be obtained from Flood Forecasting Division, Lahore. The data obtained/ received in FCC of FFC would be compiled with regard to meteorological and hydrological situations and issued in the form of Daily Weather and Flood Situation Report to all concerned organizations dealing with Flood Management at Federal as well as at Provincial Government level. In the event of an extreme situation/ High/ Very High/ Exceptionally High Flood Situation, FCC based on PMD/ FFD's reports shall also ensure issuance of Significant Flood Forecast & Warning to all concerned. Daily Weather and Flood Situation Report shall also be available on FFC's official website (<https://ffc.gov.pk/>).

3. FCC Duty Official would be available at Telephone No. 051-9244621 & 051-9244616 on 24-hours basis including Saturdays, Sundays and all National/ Closed Holidays during the entire Monsoon Season 2024 from 15th June to 15th October 2024. Information desired by any Ministry/ Division/ Department with respect to Tarbela, Chashma, Mangla reservoir position and major/secondary rivers/ important flood generating nullahs flow data can be obtained through the above mentioned telephone numbers. The list indicating name, designation & other related details of concerned officers of Federal Flood Commission is attached as **Annexure-I**.
