Sub: 2<sup>ND</sup> MONSOON 2024 REVIEW MEETING OF FEDERAL FLOOD COMMISSION, HELD ON 15<sup>TH</sup> JULY 2024 IN THE OFFICE OF CEA/CFFC, ISLAMABAD

I have been directed to refer to the subject cited above and to say that in the subject captioned meeting, besides others, the issue of RBOD-I&III was also discussed. The representative of WAPDA (G.M South WAPDA) was asked about the Contingency Plan for protection of RBOD-I&III from any further damage(s) due to any anticipated potential floods during the current Monsoon Season-2024. He responded that they lacked the necessary staff, machinery, and resources to handle any flood emergency that may occure during the on-going 2024 -Monsoon Season.

- 2. It is added that WAPDA completed the RBOD-I and RBOD-III projects in 2021 and projects Handing over/ Taking over was in process. However, the 2022 floods caused damage to the drains at several locations. The PC-I for restoration is currently under review with the relevant authorities, and its approval and subsequent implementation is expected to take time. Furthermore, the Sindh Government is not inclined to take over the management and ownership of these drains due to the damages and lack of restoration. With the Monsoon 2024 already underway, it is crucial that WAPDA make efforts to provide the necessary funds and resources to the concerned parties to manage RBOD-I and RBOD-III and protect them from potential floods this season.
- 3. In view of the gravity of the situation, WAPDA is requested to kindly develop a well thoughout Contingency Plan is consultation with PID Sindh for protection of RBOD-I&III from any further damage(s) due to any anticipated potential floods during the current Monsoon Season-2024. On this issue FFC's directions earlier communicated based on March 04, 2024, April 26, 2024, June 10, 2024, July 04, 2024 and July 15, 2024 meetings are also referred.
- Matter may kindly be accorded "TOP PRIORITY".
