**Sub: REQUEST FOR DETAILS OF EXISTING AND REMOVED ENCROACHMENTS IN  
THE FLOOD PLAINS OF RIVERS RAVI, SUTLEJ & CHENAB**

In continuation to this office letter of even number dated 12<sup>th</sup> July 2024, it is stated that Honourable Prime Minister of Pakistan has constituted Disaster Response Committee to ensure effective coordination between Federal and Provincial Governments within the context of National Disaster Response Efforts, especially in light of Monsoon Season 2024. In view of the above, it is requested to kindly share a summary containing details of all encroachments in the Flood Plains of Rivers Ravi, Sutlej & Chenab (both existing and removed) alongwith their coordinates, to this office **by 22<sup>nd</sup> July 2024, 1200 hours,** for further necessary action.
