**SIGNIFICANT FLASH FLOOD/WEATHER WARNING FOR SOUTH PUNJAB, SINDH & BALOCHISTAN FOR NEXT 48-HRS**

The Flood Forecasting Division (FFD), Lahore, has issued an updated Hydro-Meteorological Conditions report:

- **Widespread thunderstorm rain of Moderate to Heavy** intensity with **Scattered Very Heavy** and Isolated **Extremely Heavy falls** is expected over Sindh along with DG Khan, Multan, Bahawalpur, Zhob, Loralai, Nasirabad, Sibbi, Kalat and Makran divisions
- **Medium to High Level Flash Flooding** is expected in the Hill Torrents of DG Khan division and in the Nullahs of Sibbi, Nasirabad, Zhob, Kalat, Larkana (Jacobabad and Qambar Shahdadkot Districts) and Hyderabad (Jamshoro and Dadu Districts) Divisions.

2. In view of the above situation, all concerned authorities are advised to remain **ALERT**, monitor the weather and flood conditions regularly and ensure fool proof precautionary measures to avoid any loss of human lives and damage to public & private properties.
