## **GLOF ALERT**

Pakistan Meteorological Department (PMD) has issued a GLOF Alert stating due to a significant rise in temperatures and upcoming weather system in Northern Pakistan, the risk of Glacial Lake Outburst Floods (GLOFs) is very likely to increase in glaciated areas of Gilgit-Baltistan and Khyber Pakhtunkhwa. The persistent high temperatures may accelerate snow and glacier melt and subsequent weather events, potentially triggering GLOF and Flash Floods incidents in vulnerable valleys and surrounding regions during the current and upcoming week.

2. All relevant organizations are advised to remain <u>Alert</u> and take necessary precautionary measures well in time to avoid loss of human lives and damages to public and private property.
