Sub: Minutes of 2nd Progress Review Meeting of FPSP-III held on 3rd July 2025, in O/o CEA & CFFC, Islamabad

2nd Progress Review Meeting of the Umbrella PC-I of Flood Protection Sector Project (FPSP-III) was held on 3rd July 2025 at 1400 hours in the Committee Room of Office of the Chief Engineering Adviser & Chairman, Federal Flood Commission (O/o CEA & CFFC), under the Chairmanship of CEA & CFFC. The list of participants is attached as Annexure-I.

- 2. The meeting started with recitation from the Holy Quran. Following the recitation and formal introduction, the Chair welcomed all participants and emphasized that purpose of the meeting was to review progress of the Flood Protection Sector Project-III (FPSP-III). The Chair recalled that Umbrella PC-1 of FPSP-III was approved by the ECNEC on June 27, 2023, at a total cost of Rs. 194.625 billion followed by issuance of the Administrative Approval on July 25, 2023.
- 3. The Chair apprised the forum that the project could not be physically commenced during the previous financial year (FY 2024-25) due to the unavailability of foreign financing in spite of PSDP allocation. He highlighted that one of EAD's key requirements for engaging with donors was the submission of approved PC-Is of the respective sub-projects.
- 4. Referring to the first Steering Committee meeting of FPSP-III held on April 17, 2025, under the Chairmanship of the Federal Minister for Planning, the Chair said that all implementing agencies must submit PC-Is of their respective sub-projects aligned with the ECNEC's approved Umbrella PC-I. Ministry of Planning, Development & Special Initiatives (MoPD&SI) would further process PC-I for approval. The Chair urged all stakeholders and implementing partners to expedite submission of PC-Is without further delay.
- The meeting then proceeded to discuss the agenda items in seriatim.

AGENDA ITEM NO. I

REVIEW THE IMPLEMENTATION STATUS OF DECISION OF 1^{ST} PROGRESS REVIEW MEETING ON FPSP-III HELD ON 31^{ST} JANUARY 2025

- 6. The Chair recalled the decisions taken during the First Progress Review Meeting of FPSP-III held on 31st January 2025, where all implementing partners and stakeholders were directed to submit PC-Is of their respective sub-projects on immediate basis. While commitments were made and timelines given for submission, the Chair expressed concern that, to date, none of the executing agencies except WAPDA, PMD, and PCRWR had submitted their PC-Is. He further stated that provinces had been advised to reflect FPSP-III in their respective Annual Development Programmes (ADPs) for FY 2025–26 with sufficient budgetary allocations, as the project financing was based on 50:50 cost-sharing formula between the Federal and Provincial Governments. However, none of the provinces shared any update on allocations in their ADPs.
- 7. The Chair emphasized the urgent need for early submission of individual PC-Is along with detailed work plans for FY 2025–26. He then invited the provincial and federal line agencies to provide updates on the status of PC-I submissions.
- 8. The representative of the Irrigation Department, Government of Punjab, informed that PC-I of one of the sub-projects had been submitted to the P&D Department Punjab for PDWP clearance, while the PC-I of another sub-project was under preparation and expected to be finalized soon. Once cleared, both the PC-Is would be submitted to FFC for further processing. He added that a token allocation of Rs. 1.00 million had been kept under Punjab's ADP 2025–26 for FPSP-III.

- 9. The representative of PID Sindh informed that forty (40) sub-projects had been included under FPSP-III for Sindh. The PC-I for the "Reconstruction/ Rehabilitation of Malir Weirs I, II, III & Thado Dam," had been submitted to the Ministry of Water Resources through iPAS following PDWP clearance. The Chair shared that FFC had already examined the document and forwarded detailed observations to the Ministry of Water Resources for clarification and necessary amendments by PID Sindh. The representative stated that no comments had yet been received by PID Sindh, however once received, they would respond promptly. The Chair urged early submission of the remaining PC-Is by PID Sindh to FFC.
- 10. The representative of the Irrigation Department, Government of Khyber Pakhtunkhwa, informed that thirty-one (31) sub-projects had been included of KP under FPSP-III. The PC-Is for all sub-projects had been prepared after feasibility studies and submitted to the P&D Department KP for PDWP clearance. However, clearance had been delayed due to the queries regarding financing mechanism. These queries had been addressed, and it was expected that PDWP would now grant approval, after which the PC-Is would be forwarded to FFC.
- 11. The representative of Irrigation & Water Management, Gilgit-Baltistan, apprised the forum that out of ten (10) sub-projects, PC-Is for three (03) sub-projects located in Diamer, Shigar, and Nagar had been completed by the consultants following detailed feasibility studies and would soon be submitted to GB-PWD. Preparation of PC-Is for the remaining seven (07) sub-projects was underway and likely to be completed by the end of August 2025. The Chair stressed timely submission of all PC-Is, supported with feasibility studies, in line with the Steering Committee's direction to initiate work at the sub-projects through PSDP.
- 12. The representative of Irrigation & Small Dams, AJ&K, stated that out of four (04) sub-projects under FPSP-III, two flood protection schemes had been submitted to FFC in 2023. Following a visit by FFC's Monitoring Team, changes in scheme locations were advised. These schemes were then reviewed during FFC's 2nd Scrutinizing Committee meeting held on 18th December 2023, where they were deferred for second site visit. The representative requested the Chair to schedule the visit. The Chair agreed that the visit of these schemes would be carried out by FFC's Monitoring Team comprising of GIS & Hydrology experts.
- 13. The representative of PMD shared that two sub-projects of PMD under FPSP-III had been merged into a single scheme following the decision of Scrutinizing Committee meetings held on 18th September and 18th December 2023. The merged PC-I had been submitted to the Ministry of Water Resources via iPAS. Observations received from the Ministry were responded through FFC. FFC's Senior Engineer (Floods) stated that the observations had not been fully addressed and that a compliance report had been prepared and will be shared shortly. The Chair advised PMD to submit final PC-I at the earliest after addressing the Ministry's comments.
- 14. The representative of WAPDA informed that PC-Is for four (04) sub-projects and PC-II for one (01) sub-project included under FPSP-III had been cleared by FFC's Scrutinizing Committee meeting on 18th December 2023 and were currently under process with the Ministry of Water Resources. The Chair advised WAPDA to maintain close coordination with the Ministry for timely submission of PC-Is to the Ministry of Planning, Development & Special Initiatives for formal approval.
- 15. The representative of PCRWR informed that PC-Is of three (03) sub-projects were submitted via iPAS in 2024. Two (02) were returned by the Ministry of Water Resources with comments, which were discussed with FFC. However, resubmission could not be done due to iPAS closure by PD&SI Division. The Chair advised PCRWR to remain in contact with the Ministry and upload the corrected PC-Is as soon as iPAS was re-opened.

- 16. After detailed discussions, following decisions were made:
 - (i) Provincial Irrigation Departments of Punjab, Sindh, Khyber Pakhtunkhwa and Balochistan, Irrigation and Small Dams Department of AJ&K and Irrigation & Water Management Department of Gilgit-Baltistan, shall efficiently submit PC-Is of priority sub-projects of FPSP-III proposed to be implemented/ take off during financial year 2025-26.
 - (ii) PIDs/FLAs will submit their respective Work Plans for the financial year 2025–26 within a weeks' time.
 - (iii) Provincial Irrigation Departments of Punjab, Sindh, Khyber Pakhtunkhwa, and Balochistan submit details of matching fund allocations made under their provincial ADPs for the current financial year for the implementation of FPSP-III.
 - (iv) Pakistan Council of Research in Water Resources (PCRWR) will submit final PC-Is for its sub-projects under FPSP-III in case those are returned by the Ministry of Water Resources through iPAS.
 - (v) WAPDA and the Pakistan Meteorological Department (PMD) will submit their respective PC-Is on iPAS duly addressing and incorporating the observations of the Ministry of Water Resources, once the iPAS system is reopened by the Ministry of Planning, Development & Special Initiatives.

AGENDA ITEM NO. II

REVIEW OF IMPLEMENTATION OF THE DECISIONS TAKEN IN THE 1ST PROJECT STEERING COMMITTEE MEETING HELD ON 17TH APRIL 2025.

- 17. The Chair informed the forum that the first Meeting of the Project Steering Committee (PSC), established for the coordination and management of the Umbrella PC-I of the Flood Protection Sector Project (FPSP-III), was held on Thursday, 17th April 2025, in the Committee Room, P-Block, Pak Secretariat, Islamabad. The meeting was chaired by the Federal Minister for Planning, Development & Special Initiatives and the minutes were circulated by FFC on 3rd June 2025 after approval of competent authority to all stakeholders with a request for early submission of the compliance status on the decisions taken during the meeting, however so far no compliance status had been received from the PIDs/FLAs. He also requested the stakeholders for early submission of the PC-1s of sub project in accordance with the decision of the Steering Committee meeting.
- 18. After detailed discussions, following decisions were made:
- (i) All the Executing Agencies will submit status of implementation of the decisions taken during 1st meeting of PSC in one week.
- (ii) PIDs and FLAs will submit on priority the PC-Is of the sub-projects proposed for Yen Loan financing (as listed in Annexure-II) on immediate basis to facilitate the arrangement of foreign financing through the Economic Affairs Division (EAD).

AGENDA ITEM NO. III

CONSULTATION ON THE INSTITUTIONAL RESTRUCTURING OF FEDERAL FLOOD COMMISSION

19. The Chair apprised the participants that the forum of Federal Flood Commission (FFC) was created in 1977. He further elaborated that after 2010 floods, on the directions of the Supreme Court of Pakistan under Constitution Petition No. 62/2010, the then Ministry of Water and Power reconstituted the Commission vide Notification No. 3(22)/2015-Water dated 9th July 2015.

- Program (CDREP), one of the policy actions required preparation and submission of Bill for the institutional restructuring of the Federal Flood Commission and its approval by the Government. In this regard, the Asian Development Bank (ADB) had extended Technical Assistance for drafting of the Bill by hiring two institutional reforms consultants (foreign & local). The Chair further informed that the earlier prepared draft Bill was circulated among PIDs & FLAs. The response received from all stakeholders had been incorporated in the present draft prepared by the Institutional Reform Consultants appointed by the ADB. The final draft of the Bill had been submitted to the Ministry of Water Resources on 24th June 2025 for further processing and necessary approvals.
- 21. He explained that functions and composition of the proposed re-structured FFC's Bill remained largely consistent with the earlier notified structure. However, under the new arrangement, the FFC would be legally empowered to issue No Objection Certificates (NOCs) for the construction of structures along and across the rivers to ensure safety of public and to avoid bottlenecks in the smooth river flows. None of the participants raised any comment or observation on the matter.
- 22. It was unanimously agreed by all stakeholders to further process the Bill for restructuring of FFC for approval by the relevant fora of GoP.

AGENDA ITEM NO. IV STATUS OF REMOVAL OF ENCROACHMENTS

- 23. CEA & CFFC raised the critical and long outstanding issue of encroachments in the flood plains/ waterways that hindered the smooth flow of water. He highlighted that the said issue had been discussed in several meetings of the Senate Standing Committee on Water Resources, wherein the Honourable members had shown their dis-satisfaction over the presence of encroachments in the waterways of the rivers and had directed to remove all the illegal construction within the flood plain. He then requested the representatives of the Provincial Irrigation Departments (PIDs) to submit to FFC detailed status of removal of encroachments in the waterways/ floodplains for onward submission to Senate Standing Committee on Water Resources. He also advised to share with FFC the details of removed encroachments alongwith their coordinates and dates of action/ removal so that the same could be shared with SUPARCO for verification. Subsequently, following decisions were taken:
 - i. Irrigation Departments of the Punjab, Sindh, KP, Balochistan, AJ&K and GB will share updated status of encroachments removed containing their coordinates, status and nature and removal date on the prescribed Excel format already circulated among concerned organizations.
- ii. Upon receipt of the above information, FFC will forward the same to SUPARCO, who will carry out verification and submit report to FFC.
- 4. The meeting ended with the note of thanks from the Chair.
