WEATHER ALERT FOR LASBELLA, KHUZDAR, AWARAN, JHAL MAGSI, USTA MUHAMMAD AND GWADAR DISTRICTS (BALOCHISTAN PROVANCE) FOR NEXT 48 HOURS

Pakistan Meteorological Department (Regional Meteorological Centre) Western Bypass, Brewery, Quetta has issued a **Weather Alert** stating that:

- Widespread Heavy to Very Heavy rains/ thundershowers, Extreme Heavy at times is expected in Hub, Lasbella, Awaran, Khuzdar, Jhal Magsi, Usta Muhammad Districts including Sonmiani.
- Moderate Rain/ Thundershowers are also likely at scattered places in Kech, Gwadar (Gwadar, Pasni, Ormara), Surab & Southern parts of Washuk Districts during this period.
- Extreme Heavy Falls in Wadh, Khuzdar, Bela, Ormara, Makola, Din Muhammad, Hingol Valley and surrounding may produce extreme **Flash Flooding** during the next 48 hours.

All concerned organizations are advised to remain **Vigilant** and take all necessary precautionary measures well in time to avoid loss of precious human lives and damage to private and public property.
